## **TRANSCRIPT**

June 21, 2022 911 call 22174333

P:police department, this is
K: This is Kilynn Schueler with the Williamson County Republican Party. I think we have called to tell you guys we were planning on having a situation tonight, at our board meeting and we have a problem. Here at our office.
P: What's the address?
K: It's 725 Cool Springs Blvd, suite 600. We have several people demanding entrance to our meeting and they won't go away. Our chairman called and let you know ahead of time. We are also expecting some protesters downstairs and our private security is not here yet.
P: What did you say your name was?
K: Kilynn Schueler (spells out). There is a group and it's growing, in the hallway, demanding entrance to our board meeting.
P: Are they being violent?
K: Not yet. Our private security got here but we may need some backup because they're yelling and It's getting ugly. They are not listening to any of us trying to get them out of the building.
P: Can you tell if anyone is armed?
K: Not that we can tell
P: And you said you are expecting protest as well?
K: Yes
P: Ok, you said its growing, approximately how many people are out there?
K: In our office, standing in the office, that won't leave 1,2,3,4, about 1010 or 12
P: Ok. My partner is getting officers dispatched. Has it been physical at all between any of the parties involved?
K: Not that I can see, yet.  But they are video taping everything.
P: Ok, alright, Kilynn my partner is dispatching police to you. Are you comfortable with me disconnecting

K: You, I'll stay online until they get here.

or do you want me to stay on the line until they get there?

P: Let me know if it escalates, I will have to speak with my responders, so if there is a moment that you can't hear me, I'll still be able to hear you. Ok?

K: OK, thank you.

P: Yes ma'am

K: The police are on their way. I want them out of the building. That's Natalie.

They want to video it and play on internet afterwards.

It's not happenin'

And I don't want them standing their videoing through the window either.

Because he is already videoing everything out there.

P: So yall have asked them to leave and they refuse?

S: Yes, and the building closes at 6 o'clock and the office that they're standing in closes at 5 and they refuse to leave the building. They refuse to leave the office space.

They're with Williamson Families. [Note, WF had no hand in organizing this]

SEC member: (inaudible) Special board meeting.

K: and they don't want us to get rid of Sean Raesemann. (Inaudible)

SEC member (female): it is a violation...

K: Yes, exactly. It's small, but I will just say this, it's one of many.

P: What's going on now?

K: They are all standing there, refusing to leave. They will not get on the elevator and leave, and they are still standing in the building and the office space.

P: Ok

K: And we have Private Security telling them to leave and they still won't leave.

P: Ok. Are they aware the police have been called?

K: I don't know. Do you want me to go tell them that the police have been called or should they just be surprised?

SEC member, (Male): just let them be surprised.

K: We thought we would let them be surprised. Because it will just make them angry and they will start videotaping stuff and do a whole smear campaign on the internet, politics has gotten so ugly.

P: My officers should be arriving on the scene at any moment. You let me know whenever you see them.

K: OK

P: And they are inside the building, correct?

K: Yes, they are inside the office space, the rented office space that closes at 5 and they refuse to leave, and they're standing, most of them are standing by the elevator.

P: Ok

K: Chad, we may need an extra chair, you can sit over there by Debbie if you want to, that chair is empty.

P: What is this meeting in regard to?

K: Uh, it's a Republican Party meeting. We just have some, I guess hostile info... it's really none of their business what we're doing.

P: Ok

K: But we were having a board meeting for the Republican Party. We're having an Executive Session Meeting for the Republican Party. In which some of the business that is happening today, they don't really like. So, they are coming to influence the outcome.

P: Ok, let me know whenever you see my officers there on scene

K: We have 2 security guards here now and there's 1 person that is absolutely refusing to leave. She is just sitting there, refusing and everybody else is inside the elevator. There's probably 14 people now.

P: Ok

K: Ok, 4 people have gotten on the elevator. One of them was Sandi Wells.

SEC male: Yeah

P: Are they going down?

K: umm, more keep coming up.

Who is this person sitting in the chair right there?

Yeah.

No, right there.

This blond over here sitting over here with her phone.

No, over here.

No, they're not leaving.

P: what floor are you on?

K: 6 <sup>th</sup> floor
P: 6 <sup>th</sup> floor?
K: Yeah
Why is he in a
K: Yeah the police are here
P: Ok, im going to go ahead and disconnect
